4	23-117-101. Letter of support for casino applicant.		
5	(a) Pursuant to The Arkansas Casino Gaming Amendment of 2018, Arkansas		
6	Constitution, Amendment 100, the Arkansas Racing Commission shall require a		
7	casino applicant for a casino license in Pope County and Jefferson County to		
8	submit:		
9	(1) Either a letter of support from the county judge or a		
10	resolution from the quorum court in the county where the proposed casino is		
11	to be located; and		
12	(2) If the proposed casino is to be located within a city or		
13	town, a letter of support from the mayor in the city or town where the		
14	proposed casino is to be located.		
15	(b) A letter of support from the county judge or a resolution of		
16	support from the quorum court, and from the mayor, if appropriate, required		
17	under subsection (a) of this section shall be dated and signed by the county
