## A RESOLUTION IN SUPPORT OF ELITE CASINO RESORTS, LLC/RIVER RIDGE CASINO RESORT, LLC, TO OPERATE WITHIN THE CITY OF RUSSELLVILLE, ARKANSAS, AND FOR OTHER PURPOSES

WHEREAS, the Committee at its public meeting on October 14, 2019, recommended to the City Council that Elite Casino Resorts, LLC/River Ridge Casino Resort, LLC, ("Elite") be selected and supported by the City Council.

## NOW, THEREFORE, BE IT ORDERED BY THE CITY COUNCIL OF THE CITY OF RUSSELLVILLE, ARKANSAS, OF THE FOLLOWING:

**SECTION 1:** The recitals in the Preamble of this Resolution is hereby incorporated into this Resolution by reference.
